**Misc Info:**

- Penfield provides a six-week Residential Intensive Treatment Program.
- Penfield is listed on the Georgia Pardons and Paroles THOR Directory. Prior to admission, all legal issues must be resolved or postponed until treatment has been completed. Clients that are mandated must be willing to follow the terms of his/her court order.
- Intake appointments are scheduled Monday thru Fridays. No weekends.
- Must be detoxed. Penfield is not a medical facility and therefore would refer any individual requiring a medical detoxification to an appropriate facility. During the detoxification period arrangements can be made to have the person admitted upon discharge from the detox facility.
- Penfield does allow certain Rx medications to be taken. During the screening process a Penfield staff member will inform you of medications that are unacceptable.

**Client must have the following for admission:**

- a. Client must have a negative TB test or clear chest X-ray dated within the past six months.
- b. Client must have a Non-Reactive RPR dated within the past six months.
- c. Client must have a statement saying he has been successfully detoxed or does not require medical detoxification. Statement must be completed on the day of admission.
- d. Client must have attached medical forms (found on website with application info) filled out by a medical professional and fax them to us at 1-888-785-0613, on the day of admission.

**FINANCIAL CRITERIA:**

1. Program fees are normally paid upon admission. Financial arrangements must be made with the Executive Director or their designated representative, prior to approval for admission.
2. Client should have someone committed to sending him \$20 to \$40 per week for personal expenses via money order. Mainly used for tobacco products.

The programs are typically 12-18 months and consist of Bible studies, work projects, education (for adolescents), recreation and more. Many aspects of the program differ slightly between centers, such as cost, application processes, and day-to-day activities. **HOLISTIC RECOVERY**

Although many potential students do not initiate contact with potential programs, during the admissions process, most programs will want to speak directly with the applicant.

Please understand that it is your responsibility to provide transportation to and from Teen Challenge.

Adolescent Teen Challenge programs generally work with teens ages 12-17. Most adult programs work with individuals over the age of 18. There is not usually an upper range age cap in adult programs. The average age in adult Teen Challenge programs is between 25-35.

Each individual Teen Challenge program has its own policy regarding fees, tuition, and refunds. This information should be thoroughly explained, and provided in writing, at the time of admission. In most

cases, admission fees are non-refundable. In adolescent programs where finances are more of an issue, refund policies will be provided by the individual Teen Challenge programs.

There are a few Teen Challenge programs that work with the whole family. there are some Teen Challenge programs that are for mothers and their children. Call (417) 581-2181, or visit our Residential page for more details.

Most Teen Challenge programs require that you detox – preferably a medically supervised detox – prior to entering the program

A non-refundable \$750 entrance fee plus \$750 for your first month. A deposit for transportation upon leaving the program is also required for students outside the Valdosta area.

Applicant must be detoxed and drug/alcohol free. You will be drug tested upon arrival

A physical examination is required. The applicant must have the physical exam form completed by a physician and mailed, faxed or emailed to us.

BSR students are young men ages 16-20 who are placed with us through the Georgia Department of Juvenile Justice, and the Department of Family and Children Services; some students also stay voluntarily once their commitment ends. Some of our students come to us with drug abuse problems, emotional problems, or even psychological problems. We work with the student to establish goals for the duration of his time with us and help him to become a responsible, dependable adult.
